RE: Louisville Metro Corrections Overcrowding — State Inmates

Dear Commissioner Ballard:

On behalf of the ACLU of Kentucky, I write concerning one of the factors that appear to be contributing to overcrowded conditions at the Louisville Metro Detention Center (LMDC) — the state's failure to timely assume custody of state inmates from that facility. Specifically, as of August 1, 2016, there were seventy-one (71) state inmates (convicted felons and parole violators) who have remained in LMDC's custody for more than forty-five (45) days while awaiting transport to state facilities. ¹

As you are aware, § 254 of the Kentucky Constitution provides that "[t]he Commonwealth shall maintain control of the discipline, and provide for all supplies, and for the sanitary condition of the convicts." In construing this provision, the Kentucky Supreme Court has described its language as plainly requiring that state inmates *must* be remanded to the state's custody. Moreover, the Court in *Campbell Co.* further stated that "[i]t is *intolerable that any state prisoner*, regardless of space availability, should be refused an order compelling transfer into the state penal system beyond forty-five days . . . "³

Given the plain language of the relevant constitutional provision, as well as the clearly established direction from the Kentucky Supreme Court regarding its execution, the ACLU of Kentucky is concerned about the state's failure to timely assume custody of state inmates from LMDC. It appears, based on publicly available inmate population data, that the state's delay in

timely assuming custody of these state inmates may be a significant factor in LMDC's overcrowded conditions. And, of course, if those overcrowded conditions persist, additional violations of inmates' rights are likely to occur. We thus urge you to take all necessary steps to ensure that state inmates are timely transferred from LMDC to appropriate state facilities, and we respectfully request that you notify us, in writing, of your intent to do so.

Thank you in advance for your attention to this very important matter, and I look forward to your reply.
